General Terms and Conditions

Swimming: Adults participants, or the minor legal representative, certify of their ability to swim at least 82ft and to keep their head under water.

Good Health: No contraindication to sea kayaking practice.

Registration: It becomes effective upon receipt of the individual registration form and the deposit.

Payment: We request a 30% deposit at registration and the balance to be paid on the day of the event / of occurrence

Means of payment: Checks, cash, wire transfer, sport and holiday vouchers

Prices: Our prices include supervision by a qualified guide and the supply of the following equipment: sea-kayaks, paddles, life jackets, skirts and depending on the weather, neoprene suits and windproof jackets.

For more details, refer to the description of the service chosen on our website.

Insurance: We are covered by professional civil liability insurance (MMA, BP 27, 69901 Oullins. Contractually guaranteed by n°112 024 300, subscribed by SNGP CKDA.

Safety-related change: For safety reasons inherent to outdoor activities, if weather conditions, the group skills or any other event of force majeure didn't not allow us to achieve the original tour, we could decide to paddle along a less exposed part of the coastline or in an aber. We could either delay* or cancel** the journey.

If any of this occurs, we, and we alone, can take a decision, without prior notice.

Other conditions: If the minimum of 5 people is not reached, we reserve the right to delay* or cancel** the journey.

*Adjournment: For the reasons mentioned above, we may delay the journey. We will agree on a future date depending on our respective availability, **Cancellation: In case of cancellation, for the reasons mentioned above, we will refund any payment you have made. We will inform you, as soon as possible, if there are any significant changes, delay or cancellation.

We remain at your disposal for any information about the number of participants and the weather patterns. Don't hesitate to send us an e-mail or phone us.

Cancellation initiated by the customer: except in a case of force majeure, duly justified,
